### **Available Storage Services**

ECGS is currently soliciting bids for the remaining 1 BCF of firm storage service in the facility for 2012. Service can be provided at the interconnect point to Trailblazer (Point 45401) or at the Cheyenne Hub (with applicable Trailblazer Pipeline transport charges), which would provide access to supply and markets on WIC, CIG, REX, and PSCO. East Cheyenne would provide up to 2 turn service through March 2013, for minimum volumes of 250,000 Dth up to the entire 1,000,000 Dth. ECGS is also soliciting bids for longer-term storage service to begin April 2013 for terms of 1-10 years. Bids will be evaluated and awarded in accordance with the currently effective East Cheyenne FERC Gas Tariff provisions. Hub Services, both Park and Loan Service, are available from ECGS for cash and forward month transactions.
